- Floor nominations received,
- Floor nominations closed,
- Final Slate of Nominees presented,
- Elections for the following Board positions;
 - Vice-President,
 - Secretary,
 - DAL- Apparatus (1),
 - DAL - Component (1)

Note 1:

As approved by the membership at the FAMA 2015 Spring Meeting, the Vice-President is an elected position and the Vice-President will automatically progress to the positions of President and Past-President in subsequent years.

Note 2:

The Secretary position is a 2 year term.

Note 3:

The Treasurer position is a 2 year term.

Floor nominations will be accepted in accordance with *Robert's Rules of Order, Newly Revised*.

Any elected Board of Director position that is open for election is available to any qualified representative of a member company who has previously served in a leadership position within the association or as a member of the senior leadership team of a member company. The Vice President position carries the additional requirement that the candidate must have served two years on the Board prior to being elected. The Board of Directors is empowered to determine the qualifications of candidates seeking election to the Board.
