

# MEETING MINUTES FIRE APPARATUS MANUFACTURERS' ASSOCIATION GENERAL MEMBERSHIP BUSINESS MEETING Hilton Salt Lake City Center – Salt Lake City, UT September 21 and 22, 2022

Call to Order - by President Oran McNabb at 3:30 P.M. MT.

**Invocation** – Mr. Gerace provided the invocation.

**Welcome and Opening Remarks** – Mr. McNabb welcomed the attendees to the meeting and encouraged Q&A. Attendees were asked to turn their cell phones to silent.

Mr. McNabb introduced the 2022 Board of Directors and thanked them for their service.

A special welcome was extended to the two new FAMA members, and the 19 first-time attendees. The first-time attendees were recognized.

**Roll Call** – Mr. Truhler called the roll. There were 51 member companies in attendance. A quorum was declared. [See list following these minutes.]

**Proof of Notice** – Notice of this meeting was sent via email on April 22, 2022, to all members pursuant to the association bylaws.

**Review of Minutes** - After discussion and upon motion duly made and seconded, it was:

**VOTED**: To approve and enter the minutes of the February 28, 2022, and March 1, 2022, Business Meeting into the records of the association.

**Antitrust Guidelines / Non-Discrimination Policy** – Mr. Juneau reviewed the association's anti-trust guidelines and non-discrimination policy and what the guidelines mean. The association is committed to the guidelines and non-discrimination policy.

**Self-Introduction of Members** – All attendees provided a self-introduction of themselves.

**Sponsor Recognition** – Mr. McNabb thanked all the meeting sponsors and provided special recognition of the Clarion Fire & Rescue Group for their corporate sponsorship.

**Nominating Committee Report** – Mr. Toren, Committee Chair, presented.

- Mr. Toren reviewed the members of the Nominating Committee, the committee's annual objectives, and schedule.
- The Board Structure Chart and the 2023 open board positions were reviewed: Vice President, Treasurer, and Director-at-Large (Component).
- Mr. Toren presented the 2023 Board Nominations as follows:

  - Treasurer Gary Pacilio
  - Three Candidates for Director-at-Large (Component):

- Jason Witmier
- Mr. Toren provided a review of the required qualifications for candidates.
- A call for nominations from the floor was requested.
  - Mr. Pat Cahill was nominated from the floor for Director-at-Large (Component)
  - With no additional floor nominations, motion was made and seconded, to close the nominations. The floor nominations were closed.
- The four candidates for Director-at-Large (Component) were each provided two minutes to present their qualifications for Board service.
- Mr. Toren recognized the qualifications of the four nominees and asked Mr. Halpin to manage the election process.

# **2023 Board of Directors Election** – Mr. Halpin, Bylaws Committee Chair, presented.

- The Election Ballots were distributed. One ballot per every attending member company.
- All the ballots were collected.

**Treasurer's Report** - Board Treasurer Mr. Pacilio provided an overview of the following reports.

- 2021 Year End Assets and Liabilities
- Balance Sheet and Profit and Loss reports (as of 9/12/2022)
- 2022 Budget vs Actuals report
- Overall, the financials of the Association are in good shape and 2022 is tracking to be on budget.

After discussion and upon motion duly made and seconded, it was:

**<u>VOTED</u>**: To approve the Treasurer's Report as presented.

**FAMA's 75<sup>th</sup> Anniversary History Book** – Mr. McNabb reported that the balance of the FAMA 75<sup>th</sup> Anniversary History books that were in stock at the fulfillment company had been destroyed in error.

# **2025 Spring Meeting Location** – Mr. Cahill presented for the Meeting Planning Committee.

- Mr. Cahill provided a detailed presentation on two location options for the 2025 Spring Meeting. The two options presented follow:
  - Westin Rancho Mirage in Rancho Mirage, CA
  - Zachari Dunes in Oxnard, CA
- The members were asked to consider the two options presented for the 2025 Spring Meeting and be prepared to vote on Thursday, September 22nd.

#### **Education-Scholarship Committee Report** – Mr. Williamson, presented.

- Mr. Williamson announced that Brent Walker has joined the committee.
- A review of the Phillip L. Turner Scholarship program was provided.
- Special thanks to Akron Brass Company and Hale Products, the sponsors of the Scholarship.
- The committee promoted the scholarship to 14 colleges that offer programs that meet the requirements of the program.
- The 2022 Scholarship was awarded to Andrew Tivadar of the University of New Haven, CT.
- The committee also awarded another scholarship in 2022 to Elliot Paisner II of the University of Maryland, MD.
- Mr. Williamson finished his report with a review of the requirements for consideration and the application deadlines for the 2023 Phillip L. Turner Scholarship.

**2023 Board of Directors Election** – Mr. Halpin presented the election results.

- There is a tie for the Director-at-Large (Component) position between Mr. Cahill and Mr. Witmier.
- An election run-off was executed.

# **2023 Board of Directors**– Mr. Truhler presented the final election results.

- Mr. Truhler acknowledged the four great candidates for Director-at-Large and thanked them for their continued support of FAMA.
- The final election results were announced for the 2023 Board of Directors:
  - Jason Darley Vice President
  - Gary Pacilio Treasurer
  - Jason Witmier Director-at-Large (Component)

#### **Breakout Sessions** - Mr. McNabb and Mr. Halpin presented.

- Mr. McNabb reviewed the reason for the Breakout Sessions topic, Membership Qualifications. He provided an example of a FAMA member whose membership had to be revoked because they did not meet the requirements of the Association.
- The members of the Compass Committee will help to manage the discussions of each breakout group and noted that this is the first step in the process.
- Mr. Halpin provided the ground rules and reviewed the attendees group assignments.
- The results of this exercise will determine if there any needed revisions to the current required qualifications for membership.

#### **Board of Directors Report** - Mr. McNabb, Board President, provided the following update.

- Since the 2022 Spring Meeting there have been roughly 16 new additions to various committees.
- The Board of Directors is looking into opportunities to develop a FAMA owned event.
- After many years of consideration, the Apparatus Replacement Project is progressing.
- A brief review of the meeting agenda was provided and the need to stay on time was stressed.
- After a review of Poll Everywhere was presented, Mr. Lingel conducted a test.

#### Apparatus Replacement Project Report - Mr. Jason Darley provided a project status report.

- An initial proposal from Hanover Research and some examples of collateral were reviewed.
- Mr. Darley presented Hanover's cost options and timeline with a goal to introduce a data package at the 2023 Spring Meeting.

**Bylaws Committee Report** – Mr. Halpin and Mr. Whitehouse presented the proposed bylaw revisions to 13 sections. The proposed revisions were presented via email on August 18, 2022, in accordance with the Association bylaws.

- Overall, bookings are up but shipments are down due to the current supply chain issues.

- FAMA's participation in the 2023 FDSOA Apparatus Symposium has been cancelled.
- A list of possible FAMA Forum article topics were presented for the Board's review.
- Initial plans for the FDIC 2023 Technical Committee Meeting were reviewed.
- A new Graphical Symbol was presented.
- The FAMA Apparatus Safety Guide has been updated and includes 70 illustrations.
- FAMA's NFPA representatives were reviewed.
- Frame Corrosion Repair Guidelines by the Chassis Subcommittee has been published.
- Tire Life Guidelines are now in process by the Chassis Subcommittee.
- FAMA's engagement regarding CARB Engine Emissions 2024 is pending.
- The AIMS Act (American Innovation and Manufacturing Act) was discussed.
- Air Conditioning Refrigerant transition from R134 to R-1234yf. R-1234yf is the only practical alternative but, an application to the EPA is required. To support the application, the Technical Committee needs AC leak warranty data.
