

MEETING MINUTES FIRE APPARATUS MANUFACTURERS' ASSOCIATION SPRING MEMBERSHIP BUSINESS MEETING WESTIN FORT LAUDERDALE BEACH RESORT IN FORT LAUDERDALE, FL MARCH 20-21, 2023

Invocation – Mr. Lackore provided the invocation.

Sponsor Recognition – Mr. McCutcheon recognized and thanked all the meeting sponsors in order of their level of sponsorship.

Welcome and Opening Remarks – Mr. McCutcheon welcomed the attendees and provided a few opening remarks including the requirements for meeting participation and an overview of the plans for the day.

Antitrust Guidelines / Non-Discrimination Policy – Mr. Juneau reviewed the association's anti-trust guidelines and non-discrimination policy and what the guidelines mean. The association is committed to the guidelines and non-discrimination policy.

Chief Garrett Pingol, Executive Officer of Fort Lauderdale Fire Rescue – Chief Pingol welcomed the meeting attendees to Fort Lauderdale. He provided a brief description of Fort Lauderdale Fire Rescue's coverage area, the department's primary concerns, and challenges. Before closing, he thanked the meeting attendees for their support of the fire service.

Clarion Fire & Rescue Presentation – Mr. Schlett thanked the FAMA members for their business. He introduced Clarion's new staff members and provided a review of some new programs and opportunities planned for FDIC 2023.

Call to Order – by President Bert McCutcheon at 8:20 A.M. EST.

Roll Call – Mr. Truhler called the roll. There were 66 member companies in attendance. A quorum was declared. [See list following these minutes.]

Proof of Notice – December 19, 2022

Review of Minutes – After discussion and upon motion duly made and seconded, it was:

<u>VOTED</u>: To approve and enter the minutes of the September 21-22, 2022 Fall Business Meeting into the records of the association.

Mr. McCutcheon introduced the 2023 Board of Directors.

The eight (8) new FAMA Member Companies that joined the Association since the 2022 Spring Meeting were recognized.

The 14 First-Time Attendees were recognized and presented with a welcome gift.

All attendees provided a self-introduction of themselves.

Board of Director's Report – Mr. McCutcheon thanked the members for the honor to serve as the 2023 FAMA Board President. He shared how he initially became involved with FAMA and the positive experience it has been. He assured the members that the association is healthy. Although the association has lost some members, it has gained more new members. Mr. McCutcheon encouraged the first-time attendees to get involved with committees and work towards serving on the Board.

Treasurer's Report – Mr. Pacilio provided a Summary Report of Fiscal Year 2022 through the following reports. [See slides for details.]

- An overview of Total Income and Expenses for the years 2016-2022
- Assets, Gross Profits, Net Income for 2018-2022 YTD
- The Balance Sheet as of December 31, 2022 with comparison to 2021
- 2022 Profit and Loss Report with comparison to 2021
- Within the reports, details were provided for any major differences to the prior year.

Mr. Pacilio provided a Summary Report of Fiscal Year 2023 through the following reports.

- The Balance Sheet as of March 15, 2023 with comparison to 2022
- 2023 Budget vs Actuals YTD
- Within the reports, details were provided for any major differences to the prior year.

Mr. Pacilio noted with consideration of the decrease in meeting attendance and sponsorships, the Board will manage the budget conservatively for the balance of the year.

After discussion and upon motion duly made and seconded, it was:

<u>VOTED</u>: To approve the Treasurer's Report as presented.

Apparatus Replacement Project Report – Mr. Darley provided a report.

- Hanover Research has been engaged to gather the necessary data via an online survey on Fleet Management and Maintenance. Hanover will analyze the results and provide a report. The goal is to use the data collected to develop a tool that will help fire departments justify and validate the purchase of new apparatus.
- Mr. Darley reviewed some of the proposed survey questions and the current timeline for the project.

Poll Everywhere – To gain input from the attendees during the meeting, Poll Everywhere will be used. Mr. Witmier provided a review of how Poll Everywhere works and provided a test question.

Education-Surveys Committee Report – Mr. Gerace announced that the Education-Survey and Statistics Committees are merging and will now be called the **Data & Research Committee**.

- The collection and distribution of apparatus and pump orders and delivery statistics will continue.
- The new Data & Research Committee will facilitate the collection of more actionable data for the business planning needs of member companies.
- The committee needs new members.
- Mr. Gerace requested members provide feedback on the type of data that is needed.

Statistics Committee Report – Mr. John Schultz, Committee Co-Chair, presented.

- The Committee's goal is to provide quality data in a timely manner. Mr. Schultz asked the attending member representatives to encourage the Truck Reporters to meet the committee's deadline for reporting data. Their deadline for statistical data is the end of the month after a quarter ends. He also encouraged the apparatus manufacturers to support the program by reporting statistical truck data.
- Mr. Schultz provided a review of the Committee's members, initiatives, and other projects.

The following statistical data was presented in charts and graphs:

- The North American Fire Apparatus Bookings were reviewed using a 12-month rolling average, there were 6,256 units booked, this number is up 12.0% from 2021. This number does not include ARFF, refurbs or international units.
- Total Industry Bookings and Shipments This report includes all vehicles (ARFF and refurbs units). Total units booked in 2022 was 6,584. A total of 3,851 vehicles were shipped, which is down 10.7% YOY.
- Total Fire Apparatus Sales by Product Type in 2022 (using a 12-Month Rolling Average) Pumpers continue to make up the majority of products sold with 66% of the total bookings. Three product categories represent 93% of the market (Pumpers at 66%. Aerials at 17%, and Tankers at 10%).
- Total Fire Apparatus Sales by Month (12-Month Rolling Average) Report shows the number of units booked by month for a total of 6,418 units.
- Aerial Apparatus Sales (12-Month Rolling Average) 1,117 aerial units were booked, up by 30.8 % YOY; 546 units were shipped, down -4.2% YOY.
- Pumper Apparatus Sales (12-Month Rolling Average) 4,331 units were booked, 14.1% YOY increase; 2,450 units were shipped, -8.0% YOY decrease.
- Tanker Apparatus Sales (12-Month Rolling Average) 670 units were booked, -11.6% YOY decrease; 481 units were shipped, -11.1% YOY decrease.
- Vehicles with Pumps Sales (12-Month Rolling Average) 5,670 pumps were booked, 9.9% YOY increase; 3,339 units were shipped, -6.1% YOY decrease.
- Total Industry Bookings Custom vs Commercial Chassis (12-Month Rolling Average) The annual usage for Commercial Chassis is 28.4% and 71.6% for Custom Chassis. Custom Chassis had a 3.7% increase YOY.

Technical Committee Report – Mr. Lackore and Ms. Dobbs provided a report for the committee.

- Mr. Lackore reviewed the Subcommittee leaders.
- Ms. Dobbs provided an update on the Buyer's Guide Program by Subcommittee: Body, Chassis, Electrical, Aerial, Foam, and Pump. There are currently 11 pending guides, 1 draft guide, and 34 published.
- The process for submitting Buyer's Guide through review and approval was reviewed.
- FAMA is no longer coordinating the apparatus symposium speakers for FDSOA. Companies that want to participate should contact FDSOA directly.
- A list of potential FAMA Forum Article topics was presented.

- Four new graphical symbols were presented.
- Updates for the FAMA Apparatus Safety Guide are being collected.
- An update and explanation of how the NFPA Link works was presented.
- Mr. Lackore reviewed FAMA's NFPA Representatives by the current standards.
- Aerial Ladder Spacing Initiative A NIOSH ladder climbing study has been completed. An initiative to reduce aerial ladder rung spacing to 12 inch maximum has stemmed from the results of the study.
- Canadian ULC Standard S515 has not been updated since 2013. The committee is considering relying on NFPA 1900 rather than maintaining S515.
- Tire Life Guidelines NFPA reports tire life to be 7 years. FAMA Apparatus Safety Guide reports 7 years from date of manufacture.
- The 2024 CARB Engine Emissions FAMA is currently engaging with states to determine if they will adopt CARB emergency vehicle emissions exemption.
 - Pennsylvania, New Jersey, and Massachusetts exempt emergency vehicles.
- EPA for 2027
- An update regarding the conversion from Air Conditioning Refrigerant R134 to R1324yf was provided.
- PFAS Free Foam was discussed.
 - Other New Initiatives being considered include:
 - A guide for EV Charging Infrastructure for fire stations
 - Clean Cab Guide
 - NHTSA Fire Apparatus Recall Guide
 - Engine Emissions & GHG Guide
 - Buyer's Guide Videos
 - Size and Weight by State Update
